At the start of this summer, North East Lincolnshire Health and Care Partnership advertised for the new role of Community Lay Member; someone who will champion community engagement in health and care across North East Lincolnshire. We interviewed several strong candidates for the role and made the decision to appoint two people; both Community Lay members will focus on different, but complementary, areas of community involvement.

Julie Salt has worked in health and social care for many years and was an elected community representative for Navigo between 2015 and 2019. "I am passionate about making the best use of shared resources to improve the health, care, and life experiences of everyone in North East Lincolnshire", said Julie. The Future of Health and Care in North East Lincolnshire


Accord members may be aware that in late 2020 the Government announced plans to reform the health and care system across the country, with Integrated Care Boards such as Humber and North Yorkshire, becoming statutory NHS bodies and taking on the commissioning responsibilities which were previously held by Clinical Commissioning Groups.

This is part of a move to integrated care systems where partnerships of NHS providers and commissioners work closely across a geographical area, alongside Councils and other partners such as the Voluntary and Community Sector to plan and deliver health and care services for the communities they serve. They aim to provide care which is joined-up across services and settings such as mental health and social care, hospitals, and community care. On the 1st July this year, the transfer of responsibilities to Integrated Care Boards took place, and many of the staff you will have seen at Accord events over the years, are now employed by NHS Humber and North Yorkshire Integrated Care Board.

The Humber and North Yorkshire ICB covers the four Humber local authority areas, including North East Lincolnshire; as well as York and North Yorkshire. Much of the ICB's work to integrate services will happen in these individual areas, rather than across the whole footprint; each local authority area will have its own 'Place' system operating to undertake this work. This system has been operating in North East Lincolnshire for several years as the NEL Health and Care Partnership (formerly the Integrated Care Partnership.) The Partnership is made up of health and care organisations such as Care Plus Group, Navigo, focus, the Primary Care Networks (PCNs) and Northern Lincolnshire and Goole NHS Foundation Trust, working alongside other partners including North East Lincolnshire Council and the ICB.

In 2020, the CCG and Council launched the 'Talking, Listening & Working Together' Engagement Strategy; a commitment to involve our local communities in the planning of local services. The NEL Health and Care Partnership (NEL HCP) have now adopted this commitment as their approach to involving patients and communities in shaping services.

This summer, NEL HCP hosted a series of workshops at Centre4 in Grimsby to work with local people to develop a new model of engagement for health and social care - building on the strong foundations of the 'Talking, Listening & Working Together' commitment. Organisations from across the Partnership invited their service users, patients, and members – including



Accord, to attend these sessions to find out more about NEL HCP, and the projects it will be leading on in the coming months and years, such as the development of a Community Diagnostics Centre, right here in North East Lincolnshire. We also discussed how people currently get involved in shaping services, what works well or could be improved, and worked together to design a model of engagement for the future, which aims to be inclusive and accessible to all our communities.

took part in these sessions, and have since been involved in further work to develop the plans which came out of these sessions.

Liz, who is also the Chair of the Accord Steering Group, said: "It was great to see so many people, from all corners of our community come along to these workshops. As our health services start to work more closely together locally, and across the Humber and North Yorkshire region, it is more important than ever that we have robust processes in place to give our local people meaningful opportunities to get involved in the development of services. It was clear from the discussions we had at the workshops, that there are lots of good examples of engagement across the Health and Care Partnership; but there is more that we can do to improve things further.

"The Accord Steering Group was delighted to see NEL HCP adopting the 'Talking, Listening & Working Together' commitment as its approach to public engagement, and its plan to use Accord as one of the main vehicles for involving the public", said Liz.

The new model of engagement aims to be more accessible to local people, ensuring that we hear from people with lived experience of services; whilst also continuing to have arrangements in place to provide assurance on engagement activity for health and social care, through the establishment of a Citizens Reference Group. This Group will involve members of our Accord Steering Group, as well as public representatives of the other organisations within NEL HCP, who will work together to ensure that organisations are giving people appropriate and relevant opportunities to get involved.

Dr Ekta Elston is a local GP and the Interim Clinical Director for NEL HCP and was involved in the workshops hosted at Centre4 to develop the new engagement model. "Thank you to everyone who took the time to work with us – your input has helped us to develop a new approach to engagement, which builds on the good work which has been taking place in North East Lincolnshire over recent years", said Ekta. "There are a number of key areas of work which NEL HCP, and Humber and North Yorkshire Integrated Care Board will be focusing on in the coming months, and it will be key that we include the voice of North East Lincolnshire residents in these projects."

"As we start to move into the Winter period, the NHS and its partners will be working together to face the pressures which the colder months bring, and with the potential for Covid, Flu, and other respiratory illnesses to be circulating at high levels, it is important that we all do what we can to keep ourselves safe. A Covid booster programme is being operated for people aged 50 and over, those in care homes, and those aged 5 years and over in clinically at-risk groups; and there is also a seasonal Flu vaccine programme."

Keeping you in the loop!

In recent months, Accord members have been involved in lots of brilliant pieces of work, and we thought it was a great time to give you a quick update on some of these!

As part of the Humber Acute Services Programme, the 'Your Birthing Choices' engagement exercise was launched in June 2021 to find out what is important to people accessing maternity services in the Humber region. Over 1100 people from across the Humber took part, through either an online survey or by attending a focus group.

Team to review the **information**, **advice**, **and guidance**, which is available across several our public websites in North East Lincolnshire, including the LiveWell website - https://livewell.nelincs.gov.uk/

Over the past couple of months, they have been reviewing information about care planning, and Continuing Health Care, providing feedback on how easy the information is to find and understand, and whether it provides the information which the public need to know.

Over the coming months they will be continuing the project, reviewing information on the Mental Capacity Act, Advocacy services, and how care is paid for.
